We understand that due to the vagaries of weather and other seasonal factors, season dates and items listed to be grown are all variable and subject to change.

We understand and agree that the management at Victory Acres CSA will and have done everything possible to prevent these negative factors from damaging our naturally grown local foods.

We understand that there are no refunds.

We understand that Victory Acres will not be held liable for any injuries/accidents to farm members on the farm.

We understand as farm members that we are welcome on the farm-hike, picnic, and camp-except on Sundays.

Delivery charge is assessed to cover cost of fuel. Drop-off sites are subject to change as needed.

We understand that we will receive a "share" of the produce and that the produce will be divided as equally as possible between the members of the CSA.

We understand that Victory Acres will take our suggestions and the suggestions of all other members into account in forming the planting list. We understand that the planting list we receive is subject to change.

We understand that VICM cannot hold our portion, and if our produce is not picked up at the chosen pick-up site during the weekly, designated time period, we forfeit our portion for the week.
